To erect, construct, alter, maintain, sell, lease, mortgagee, improve, develop, and control all or IX. any part of the property or the building of the society necessary or convenient for the purpose of the attainment of the aims and objectives of the society.

To engage employ or hire appropriate staff workers, legal experts and other professionals X. attorneys, chartered accountants and agents for the work and furtherance of the aims and objective of the society and to pay their wages, salaries, stipends, fees etc.

To conduct research in education and other disciplines on the different subjects such as XI. agriculture, technical and medicine.

To accept donations, grants, presents gifts and other offerings in the shape of movable and/or XII. immovable properties for the attainment of aims and objectives of the society.

To open, found, establish, promote, setup, run, maintain, assist, finance, support and/or help the XIII. various community development programmes.

XIV. To fight against the social evils and to approach the competent courts to safe guard the rights of the general public.
