01. Name of the Society : VANI SRI EDUCATIONAL SOCIETY

1. Aims and Objects :

- I. To assist and engage in social service activities with the view to improve the economical, Educational, Technical environmental and social conditions of the poor, the destitute and the members of the backward community irrespective of caste and creed.
- II. To assist all such institutions engaged in social Service and to provide the basic necessities of life such as food, clothing and shelter to the deserving persons irrespective of caste and creed.
- III. To assist for the basic educational and medical facilities and housing accommodation to the poor of the society irrespective of caste and creed.
- IV. To set up and run structures and institutions to study, to improve and to train people in the field of agriculture, Education, Medical, animal husbandry, technical skill, self employment trades, social work and the similar subjects contributing to the overall welfare and development of the people of our country.
- V. To start, establish, run, take over the existing or manage and maintain general, vocational, technical, Medical, Paramedical, Professional Schools, Colleges and Institutions and also Training Institutions.
- VI. To promote literacy, cultural and social activities by conducting various awareness programmes.
- VII. To provide food, cloths, shelter, medical aid, stationery, transportation, libraries, laboratories, reading rooms, hostels, play grounds and other possible facilities to the students, need people and also the members of the society.
- VIII. To purchase acquire the lands buildings and sell out the lands for the purpose of the society and to construct the building.
- IX. To erect, construct, alter, maintain, sell, lease, mortgagee, improve, develop, and control all or any part of the property or the building of the society necessary or convenient for the purpose of the attainment of the aims and objectives of the society.
- X. To engage employ or hire appropriate staff workers, legal experts and other professionals attorneys, chartered accountants and agents for the work and furtherance of the aims and objective of the society and to pay their wages, salaries, stipends, fees etc.
- XI. To conduct research in education and other disciplines on the different subjects such as agriculture, technical and medicine.
- XII. To accept donations, grants, presents gifts and other offerings in the shape of movable and/or immovable properties for the attainment of aims and objectives of the society.
- XIII. To open, found, establish, promote, setup, run, maintain, assist, finance, support and/or help the various community development programmes.
- XIV. To fight against the social evils and to approach the competent courts to safe guard the rights of the general public.




